> So I received word the other day that Kevin is offering to withdraw from Vassar if I consent. That would entail me approving a written statement composed by the Vassar Lawyer. If I do approve the statement then he will be permanently removed from Vassar. However, if I do not approve the statement the case will continue. As you know, I plan to write about the case publicly and try to change policy at Vassar with Title IX cases. Kevin has hired a lawyer and I am concerned that if I do speak publicly then I open myself up to a lawsuit. I know your father is a lawyer and I was wondering if he knows anyone who I could consult with.
